The Tour Operator reserves the right at its discretion to change the sequence or alter any part of the itinerary or hotel accommodations, without prior notice for any reason; but in the event of substantial reduction in the services rendered, a proportionate refund will be made to tour participants upon written request to the Tour Operator. If there is a major change in the itinerary, participants will be notified before departure and offered an opportunity to cancel with full refund.

In the absence of negligence by the Tour Operator, the Tour Operator accepts no responsibility for losses or additional expenses due to delays or changes in air or other services, sickness, weather, strikes, or other causes. All such losses or expenses will be borne by the passenger.
